15 crore kids, youth out of formal education system: Pradhan

NEW DELHI: At least 15 crore children and youths are out of the country's formal education system, and roughly about 25 crore population is below the primary definition of literacy, Union Education Minister Dharmendra Pradhan said. He was addressing a session on "Job creation and entrepreneurship" organised by the CII. "If we take into account the numbers of children and youths between the age of 3-22 years who are enrolled in govt, private and charitable schools, the cumulative figure from all the verticals is around 35 crore while (the country's) population in the particular age group is around 50 crore," Pradhan said.

Delta Plus...

They have already tested negative for the virus after treatment. Apart from them, two others, who had not received any jab so far, too managed to beat the infection. While one of them is a 22-year-old woman, another is a two-year toddler.

Health commissioner Akash Tripathi said, "Only two deaths have been reported so far due to Delta Plus in Madhya Pradesh. One death was reported from Ujjain and another from Ashok Nagar.

Both had not received any jab. Only 12 cases of Delta Plus have been detected in Bhopal, Ashok Nagar, Raisen, Datia and Ujjain."

According to health experts, the Delta variant was the cause of deadly second corona wave that struck the country between March and May. The health infrastructure couldn't match the requirements, thousands were killed and lakhs were infected. The transmissibility and attack rate of the Delta variant are higher than the other variants of the virus.

HC seeks details...

A division bench comprising Chief Justice Mohammad Rafiq and Justice V K Shukla said, "We direct Additional Chief Secretary of the Department of Medical and Health, Government of Madhya Pradesh to place on record the current and exact position with regard to the number of patients of black and white fungus or any other kind of similar disease in the state." The high court also directed the authorities to ensure that all such patients are provided Amphotoericin B and other medicines as prescribed to them by doctors, not only in Jabalpur, but also in hospitals inthe other cities, like Gwalior, Indore, Bhopal and elsewhere in the state, so that no patient suffers due to lack of medicines, Nagrath said.

The amicus curiae submitted that last week, family members of more than 50 patients suffering from black fungus infection, who are still admitted to the Government Hospital at Jabalpur, had gheraoed the state officials, alleging that the patients were not given Amphotericin B medicine, putting their lives in danger.

Those signing the joint statement were Mallikarjun Kharge, Adhir Ranjan Chowdhury and Anand Sharma of Congress, TR Baalu and Tiruchi Siva of DMK, Sharad Pawar (NCP), Ramgopal Yadav (SP), Sanjay Raut (Shiv Sena), Manoj Jha (RJD), Elamaram Kareep (CPI-M), Binoy Viswam (CPI), ET Mohd Basheer (IUML), NK Prechandran (RSP) and Thomas Chazhikadan (Kerala Cong-M).

The leaders blamed the government squarely responsible for the stalemate and used its "brute majority" to push through the legislative agenda in violation of established procedures, conventions and spirit of Parliamentary democracy.

"To divert attention from its own conduct and actions, the Government has unleashed a state-sponsored, malicious and misleading campaign by blaming the combined Opposition for the disruption of Parliament," they added.

Rahul Gandhi, who joined the MPs' march from the Parliament House to Vijay Chowk after a meeting in the chamber of Kharge, accused Prime Minister Modi of selling the "soul of the nation". Shiv Sena's Sanjay Raut said scene in the Rajya Sabha on Wednesday was as if the marshal law has been imposed.

Till justice is given to the poor girl, we will continue to raise this voice," he said.

On Instagram, the Congress said: "Twitter India has locked the official handle of the principal opposition party. This is an unprecedented attack on the voice of the people." The head of the Congress's social media department, Rohan Gupta, said the party's official Twitter handle and around 5,000 accounts of its top leaders and workers have been blocked by the website. He alleged that Twitter is acting against the opposi-

tion party leaders under pressure from the government. "Twitter is clearly acting under government's pressure as it did not remove the same pictures shared by the Twitter account of the National Commission for Scheduled Castes for a few days," Gupta said.

The Twitter accounts of All India Congress Committee (AICC) general secretaries Surjewala, K C Venugopal, Ajay Maken, the party's whip in the Lok Sabha Manickam Tagore, Assam in-charge and former Union minister Jitendra Singh and Mahila Congress president Sushmita Dev have also been blocked, the party said.

Squeezing Kabul...

Thousands of people have fled their homes amid fears the Taliban will again impose a brutal, repressive government, all but eliminating women's rights and conducting public amputations, stonings and executions. Peace talks in Qatar remain stalled, though diplomats met throughout the day.

The latest US military intelligence assessment suggests Kabul could come under insurgent pressure within 30 days and that, if current trends hold, the Taliban could gain full control of the country within a few months. The Afghan government may eventually be forced to pull back to defend the capital and just a few other cities in the coming days if the Taliban keeps up its momentum.

The onslaught represents a stunning collapse of Afghan forces and renews questions about where the over \$830 billion spent by the US Defence Department on fighting, training those troops, and reconstruction efforts went - especially as Taliban fighters ride on American-made Humvees and pickup trucks with M-16s slung across their shoulders. Afghan security forces and the government have not responded to repeated questions from journalists over the days of fighting, instead issuing video communiques that downplay the Taliban advance. On Thursday, the militants raised their white flags imprinted with an Islamic proclamation of faith over the city of Ghazni, just 130 km (80 miles) southwest of Kabul.

India assures support to Afghan Hindus, Sikhs

India on Thursday said that its mission in Kabul is in touch with the Afghan Hindu and Sikh community members and will ensure that they get all necessary assistance. Dismissing speculative reports on closure of the Indian embassy in Kabul, the government requested Indian nationals in Afghanistan to look at ways to come back while commercial fights are still on.

The External Affairs Ministry also clarified at the weekly briefing that there is no formal evacuation mechanism.


